


This proposal solicitation document is available in an Adobe Acrobat (pdf) format. Any alterations to this document made by the proposer may be grounds for rejection of proposal, cancellation of any subsequent award, or any other legal remedies available to the Sumner County Board of Education.



- 3. In addition, for all vendors with annual purchases in excess of \$50,000 (if a business license is required), a business license must be on file in the finance department, or the requisitioner must submit a copy with the purchase order requisition form or the payment requisition form, as applicable.
 - **x** Proposal must include point-by-point responses to the RFP.
 - **x** Proposal must include a list of any exceptions to the requirements.
 - **x** Proposal must include the legal name of the vendor and must be signed by a person or persons legally authorized to bind the vendor to a contract.
 - **x** If applicable, proposal must include a copy of the contract(s) the vendor will submit to be signed.
 - **x** Any and all proposal requirements must be met prior to submission.
 - x The bidder understands and accepts the non-appropriation of funds provision of the Sumner County

Each bidder or respondent to the RFP who may have employees, contractors, or agents working on Sumner County properties shall provide copies of current certificates for general and professional liability insurance and for workers' compensation of a minimum of \$250,000. The owner or principal of each respondent must also be insured by workers' compensation if they perform any of the services on School System properties. There will be no exceptions to the insurance requirement.

Payment terms shall be specified in the bid response, including any discounts for early payment. All payments, unless agreed upon differently, will be after receipt of service or product and ^ Z } } o ^ Ç approw{hof conformance with specifications.

Sealed proposals will be accepted until local time. Proposals received after that time will be deemed invalid and returned unopened to the vendor. Vendors mailing proposal packages must allow sufficient time to ensure receipt of their package by the time specified. There will be no exceptions. Proposals will be opened at an unspecified time 2,32016deadline of 1000a.m. (local time). Bids will be awarded after 3 (first), 2016.

A withdrawn proposal may be resubmitted up to the time designated for the receipt of proposals provided that it fully conforms to the same general terms and requirements.
