General Information

I. Proposal Package

All sealed proposal packages must include all of the following, when applicable. All sealed proposals shall be rejected as a nonconforming bid if any applicable item is missing.

- x Drug-Free Workplace Affidavit (Attachment 2)
- x If bid is in excess of \$25,000, a certification of no debarment must be completed (Attachment 3) Certification Regarding Debarment, Suspension, and Other Responsibility Matters
- x Certification By Contract (Attachment 4)

CERTIFICATION REGARDING DEBARMENT, SUSPENSION, AND OTHER RESPONSIBILITY MATTERS

The prospective participant certifies, to the best of its knowledge and belief, that it and its principals:

1. Are not presently debarred, suspended, proposed for debarment, declared ineligible or voluntarily excluded from participation in transactions under federal procurement programs by any federal department or agency;
2. Have not, within the three year period preceding the proposal, had one or more public transactions (federal, state, or local) terminated for cause or default; and
