2. Requirements

2.1. Contract Term

It is the intention of SCS to award a contract for a-**gee**r term beginning July 1, 2019 thru June 30, 2020. SCS reserves the right to extend the contract for an additional four (4) **geer** terms subject to agreement between both parties and approval by the SCS Board at its' regular stated meeting. SCS shall accept a reques for price increase no lather sixty (60) days prior to the current term's expiration date.

The automated solid biocide program shall use an oxidizing microbiocide to provide biological control.

The water treatmethsupplier must have the capability of testing for biological contamination and control. The supplier must also have the capability of running Legicites as required.

All existing conductivity controllers and chemical feed pumps to be used unless deemed unrepairable.

The use of the required solid feeder boards for the cooling towers **astallia**tion shall be included in the contract price. The feeder boards shall remain the property of the water treatment contractor and any maintenance required during the contract period shall also be included.
